<b>Loading, handling and transportation of equipment</b>	Operator, spectator	Injury	Low	All staff to be trained in manual handling. Manual handling to be reduced to a minimum by use of trolleys/ lifts. Loads to be properly secured. Where required, multiple persons must handle equipment.	Low	Yes
<b>Installation of equipment on site</b>	Operator, spectator, participants	Injury to operator, spectators or participants. Damage to venue.	Low	Operator must have clear, unhindered access to the setup area. Setup area to be clear and free from debris. Pre setup checks on equipment to check for damage. Equipment to be set up away from sources of water.	Low	Yes
<b>Ground type</b>	Operator, spectator, participants	Injury to operator, spectators or participants.	Low	Equipment to be installed and operated on a even ground	Low	Yes

<b>Over enthusiastic participants</b>	Operator, spectator, participants	Injury to operator, spectators or participants.	Medium	Responsible person supervising at all times.	Low	Yes
<b>User safety - Unruly behaviour</b>	Operator, participants	Injury to operator or participants	Low	Anyone thought to be behaving in an unruly manner should be asked to leave the gaming area. The croupier decision is final: refusal to abide by the croupier's guidance will result in play refusal and in extreme circumstance, closure of the table.	Low	Yes
<b>Lack of supervision</b>	Participants	Injury due to lack of guidance / supervision	Low	A fully trained croupier must be present at the equipment at all booked times, in the event that the operator is not in view, do not use the equipment.	Low	Yes

<b>Injury from flying objects</b>	Participants , spectators, participants	Injury to the face or head due to roulette ball becoming free	Low	Trained croupier is to insert the ball correctly and spin the wheel at appropriate speed to ensure that it does not come free	Low	Yes
<b>Cuts from cards</b>	Participants	Cuts on hands from cards being dealt	Low	Croupier will instructs participants to leave the cards alone until all cards are dealt	Low	Yes
<b>Overstretching</b>	Participants	Injury from over stretching across the table	Low	Croupier to collect /place cards and chips	Low	Yes
<b>Tables collapsing</b>	Participants	Injury from tables collapsing	Low	Trained staff to assemble tables. Participants are urged not to lean heavily on the tables	Low	Yes
<b>Heat</b>	Organiser, spectator, participants	Injury to spectators or participants.	Low	The equipment should not be set up near any sources of heat or naked flames.	Low	Yes

## Risk rating

### High

For example:

- fatality possible to one or more individuals however infrequent
- major injury to few individuals occurring frequently
- likelihood of long term muscular-skeletal problems affecting significant numbers of staff

**Immediate action required**

### Medium

For example:

- major injury to one/few individuals occurring infrequently
- likelihood of long term muscular-skeletal problems affecting some staff. Requires attention as soon as possible

### Low

For example:

- minor injury occurring infrequently to few staff.  
Not a priority, may need attention if not as low as reasonably practicable.
